The Robinson Bradshaw Diversity Fellowship furthers our commitment to recruit and promote talented individuals with diverse backgrounds, perspectives and experiences. Fellows will benefit from hands-on learning, participate in networking and community engagement opportunities, and receive scholarship funds to assist with their law school expenses.

Fellowship Benefits

- A paid position in our summer associate program
- Up to \$25,000 in scholarship funds
 - \$10,000 will be awarded after acceptance of a 1L summer associate position,
 - \$7,500 will be awarded after acceptance of a 2L summer position, and
 - \$7,500 will be awarded after acceptance of an entry-level associate position.
- Participation in the Leadership Council on Legal Diversity 1L Scholars program.
- An opportunity to engage in an enrichment experience of the fellow's choosing.
