June 2012 SRDP Settlements

On June 13, the Center for Medicare & Medicaid Services (CMS) announced its ninth settlement under the Voluntary Self-Referral Disclosure Protocol (SRDP). This settlement involved violations of the federal physician self-referral statute (commonly known as the Stark Law) by a hospital located in Alabama (Hospital). The Hospital disclosed under the SRDP that it violated the Stark Law by using a rental charge formula that did not satisfy the requirements of the rental of equipment exception under the Stark Law. The Hospital's violations were settled for \$42,000. Access CMS' quarterly list of "select" self-disclosures resolved under the SRDP, including this settlement, here.
